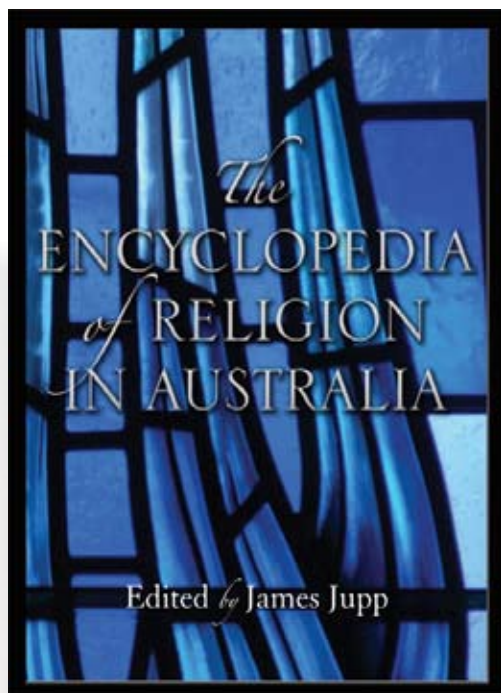

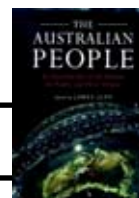

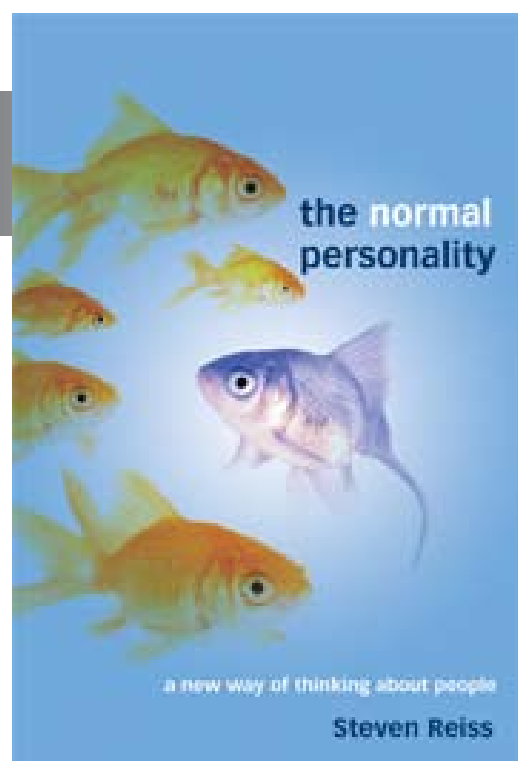

Popular Science/Psychology In *The Normal Personality*, the author argues that human beings are naturally intolerant of people who express values significantly different from their own. Because of this intolerance, psychologists and psychiatrists sometimes confuse individuality with abnormality and thus over-diagnose disorders. Reiss shows how normal motives - not anxiety or traumatic childhood experiences - underlie many personality and relationship problems, such as divorce, infidelity, combativeness, workaholism, loneliness, authoritarianism, weak leadership styles, perfectionism, underachievement, arrogance, extravagance, stuffed shirt-ism, disloyalty, disorganization, and overanxiety.

Calling for greater understanding and tolerance of all kinds of personalities, Reiss applies his theory of motivation and leadership, human development, relationships, and counseling.

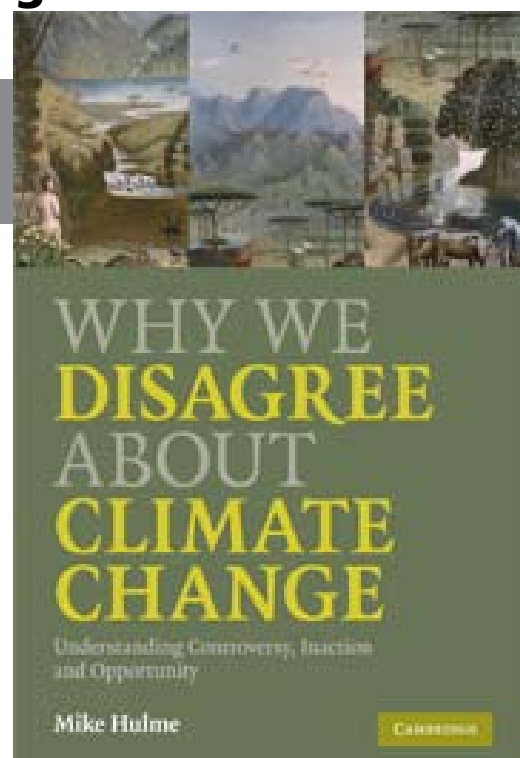

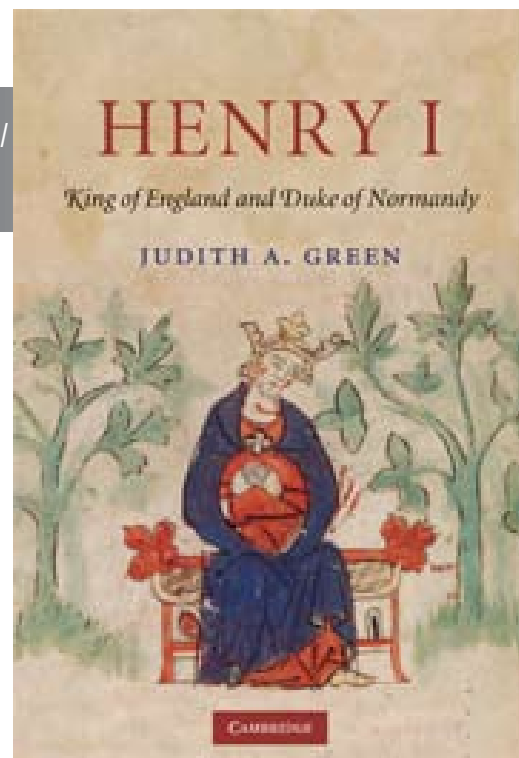

History A comprehensive biography of Henry I, the youngest son of William the Conqueror and an elusive figure for historians. Judith Green argues that although Henry's primary concern was defence of his inheritance, this did not preclude expansion where circumstances were propitious, notably into Welsh territory. His skilful dealings with the Scots permitted consolidation of Norman rule in the northern counties of England, while in Normandy every sinew was strained to defend frontiers through political alliances and stone castles.

Green argues that although Henry's own outlook was essentially traditional, the legacy of this fascinating and ruthless personality included some fundamentally important developments in governance. She also sheds light on Henry's court, suggesting that it made an important contribution to the flowering of court culture throughout twelfth-century Europe.

When should an individual be pronounced dead? When, if ever, is suicide or euthanasia wrong? Is abortion wrong and if so why?

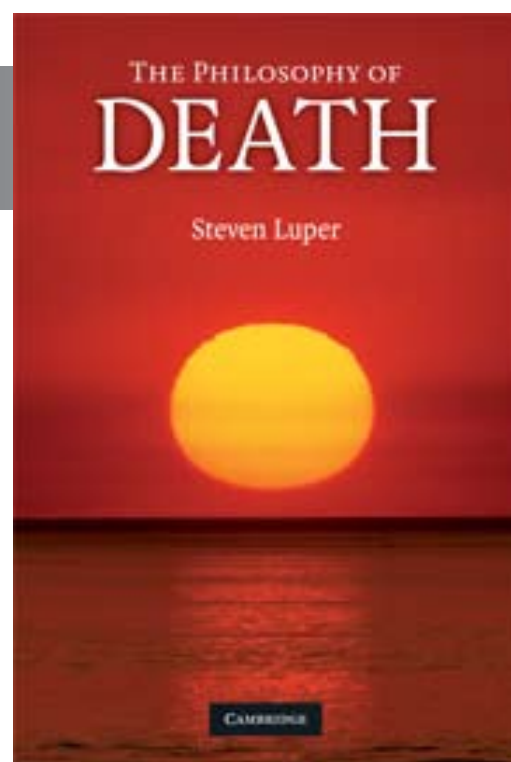

Philosophy *The Philosophy of Death* is a discussion of the basic philosophical issues concerning death, and a critical introduction to the relevant contemporary philosophical literature. Luper begins by addressing questions about those who die: What is it to be alive? What does it mean for you and me to exist? Under what conditions do we persist over time, and when do we perish? Next, he considers several questions concerning death, including: What does dying consist in; in particular, how does it differ from ageing? Must death be permanent? By what signs may it be identified? Is death bad for the one who dies? If so why?

Finally he discusses whether, and why, killing is morally objectionable, and suggests that it is often permissible; in particular, (assisted) suicide, euthanasia and abortion may all be morally permissible. His book is a lively and engaging philosophical treatment of a perennially fascinating and relevant subject.

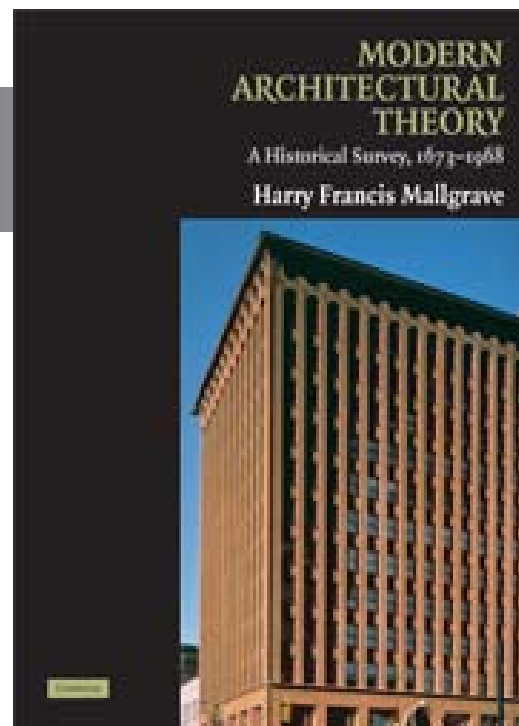

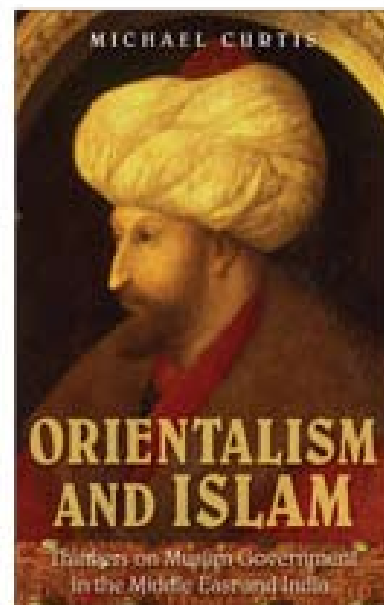

The book also criticizes the misconception that the Orient was the constant victim of Western imperialism and the view that Westerners cannot comment objectively on Eastern and Muslim societies. The book views the European concept of Oriental despotism as based not on arbitrary prejudicial observation, but rather on perceptions of real processes and behavior in Eastern systems of government.

The book includes discussion of the observations of Western travelers in Muslim countries and analysis of the reflections of seven major thinkers: Montesquieu, Edmund Burke, Tocqueville, James and John Stuart Mill, Karl Marx, and Max Weber.
