

POWER CRISIS

The Self-Destruction of a State Labor Party

Written by an insider – Rodney Cavalier, a former minister and Labor historian – *Power Crisis* is an explosive account of the self-destruction of the New South Wales Labor government, a government that has seen a turnover of four premiers in five years.

With wit and passion, Cavalier reveals the behind-the-scenes struggle for the soul of the Labor party. He describes the takeover of Labor by a professional political class without connection to the broader community or the party's traditions. This deep malaise within the ALP, reflected in falling party membership and alienation of the remaining faithful threatens to destroy good government not just in NSW, but in other states and the nation.

Based on interviews with ex-Premiers lemma and Rees, personal diaries and private writings, and informed by history (from the 1890s to the present), *Power Crisis* contrasts the current turmoil and paralysis with the stability within the NSW Labor over generations before, and asks, 'What went wrong?'
