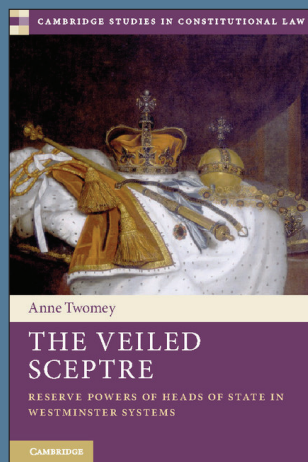

## The Veiled Sceptre

### Reserve Powers of Heads of State in Westminster Systems

Anne Twomey

This book is a comprehensive review and analysis of the exercise of the reserve powers by heads of state (including vice-regal representatives) in countries that have Westminster systems. It addresses the powers of the Queen in the United Kingdom, and those of her vice-regal representatives in the older realms of Canada, Australia and New Zealand, and also analyses exercises of reserve powers in the less studied realms.

Drawing on a vast range of previously unpublished archival and primary material, including records from the Royal Archives at Windsor Castle, *The Veiled Sceptre* contains fresh perspectives on old controversies. It also reveals large constitutional crises in small countries that have escaped the notice of most scholars. This book places the exercises of reserve powers within the context of constitutional principle and analyses how heads of state should act when constitutional principles conflict.

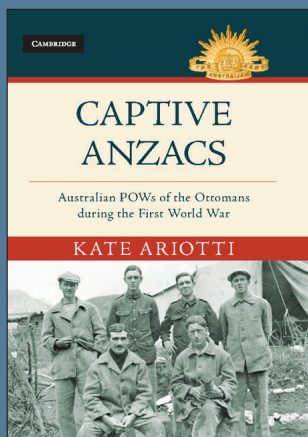

## Captive Anzacs

### Australian Prisoners of War of the Ottomans during the First World War

Kate Ariotti

During the Great War, 196 Australians became prisoners of the Ottomans. Captivity caused these men to question their position as soldiers and their role in the war, while living under the rule of a culturally, religiously and linguistically different enemy proved significantly challenging.

Overshadowed by the grief and hardship that characterised the post-war period, and by the enduring myth of the fighting Anzac, these POWs have long been neglected in the national memory of the war.

*Captive Anzacs* explores how the prisoners felt about their capture and how they dealt with the physical and psychological strain of imprisonment, as well as the legacy of their time as POWs. More broadly, it explores public perceptions of the prisoners, the effects of their captivity on their families, and how military, government and charitable organisations responded to the POWs both during and after the war.

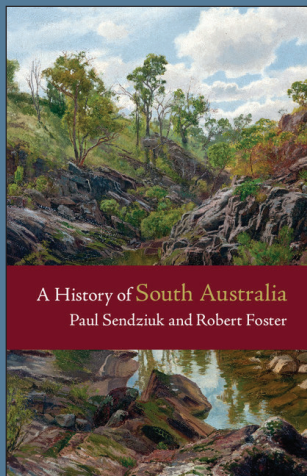

Established as a 'free' settlement, South Australia's social and political history is distinct from the other Australian colonies. In this book, Paul Sendziuk and Robert Foster provide a compelling and nuanced history of South Australia which spans from the time before European settlement to the present day.

*A History of South Australia* is structured around four central themes: the imprint of people on the land, the relationship between European settlers and the Indigenous peoples, the advance and retreat of an interventionist government and the state's distinctive socio-political formations. Sendziuk and Foster employ these themes to explore the narrative of South Australia's history, from arrival of European settlers to the social reforms and economic upheavals of the twentieth century, with the state's relationship to the rest of the world in mind. This book also offers insight into South Australia's popular memory versus its true history, and predicts where the state might go in the future.

**Paul Sendziuk** is an Associate Professor in the Department of History at the University of Adelaide. He has expertise in the histories of the twentieth century Australia, immigration, disease and public health. He is the author of *Learning to Trust: Australian Responses to AIDS*, and, with Robert Foster, the co-editor of *Turning Points: Chapters in South Australian History* and *Foundational Fictions in South Australian History*.

**Robert Foster** is an Associate Professor in the History Department of the University of Adelaide. He has published extensively in the field of South Australia Indigenous history, and is co-author of *Out of the Silence: The History and Memory of South Australia's Frontier Wars* (2012).

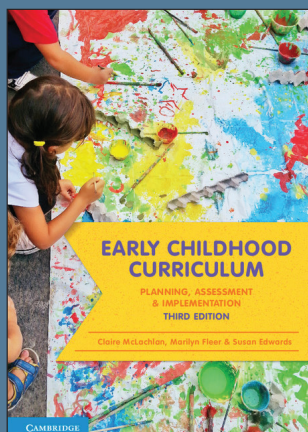

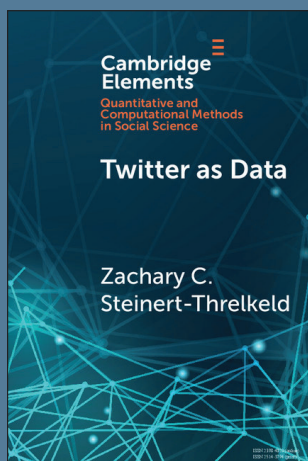

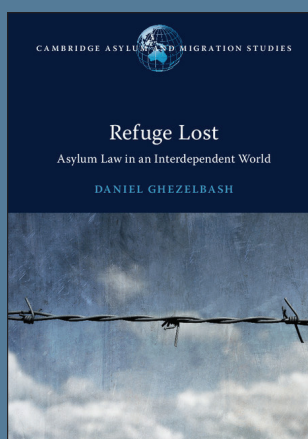

## Twitter as Data

The rise of the internet and mobile telecommunications has created the possibility of using large datasets to understand behavior at unprecedented levels of temporal and geographic resolution. Online social networks attract the most users, though users of these new technologies provide their data through multiple sources, e.g. call detail records, blog posts, web forums, and content aggregation sites. These data allow scholars to adjudicate between competing theories as well as develop new ones, much as the microscope facilitated the development of the germ theory of disease. Of those networks, Twitter presents an ideal combination of size, international reach, and data accessibility that make it the preferred platform in academic studies. Acquiring, cleaning, and analysing these data, however, require new tools and processes. This Element introduces these methods to social scientists and provides scripts and examples for downloading, processing, and analysing Twitter data.

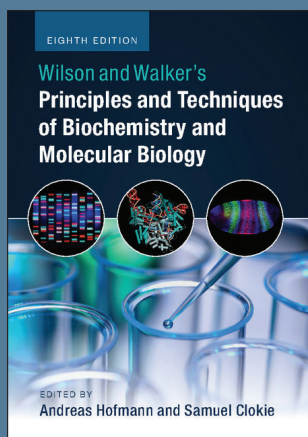
As Europe deals with a so-called 'refugee crisis', Australia's harsh border control policies have been suggested as a possible model for Europe to copy. The book examines the process through which these policies spread between the United States and Australia and the way the courts in each jurisdiction have dealt with the measures.
