

"Professor Twomey is one of Australia's foremost constitutional experts and, as would be expected, this book displays admirable scholarship, commentary which is perceptive and fair, and an impressive breadth of research. The focus is upon Westminster systems, which cover places with a variety of degrees of political and legal stability. Australia, like Canada and New Zealand, is a relatively mature parliamentary democracy, but the Queen's other realms are not all in that category. Some of the examples that are given of problems that have confronted their heads of state make our own constitutional crisis of 1975 seem comparatively peaceful.

The book contains an extensive record both of constitutional events and of advice and commentary surrounding those events. In that respect it will be an invaluable resource for lawyers and administrators for whom constitutional issues may be a matter of professional concern, as well as commentators, including journalists, for whom such issues are of interest.


It should also be remembered that, in a sense, crises of the kind recounted represent the tip of an iceberg. By their nature, the reserve powers of a head of state may be of importance even when they are not being exercised. Their very existence is often enough to quell a controversy and ensure that political conflict is conducted in a manner that respects legality and convention. This is why what is useful is not only the book's account of past events but also its analysis of the principles underlying the responses to those events. Professor Twomey explains the extent to which those principles are contestable and offers her own opinions fairly and dispassionately. It is also reassuring to observe the pragmatism and practical wisdom of the informal advice that has been given to heads of state over the course of the last century when they have been confronted with the need to act (or at least to warn of the possibility that they might act) independently of formal ministerial advice."

The Limits of Peacekeeping

The Limits of Peacekeeping highlights the Australian government's peacekeeping efforts in Africa and the Americas from 1992 to 2005. Changing world power structures and increased international cooperation saw a boom in Australia's peacekeeping operations between 1991 and 1995. The initial optimism of this period proved to be misplaced, as the limits of the United Nations and the international community to resolve deep-seated problems became clear. There were also limits on how many missions a middle-sized country like Australia could support. Restricted by the size of the armed forces and financial and geographic constraints, peacekeeping was always a secondary task to ensuring the defence of Australia. Faith in the effectiveness of peacekeeping reduced significantly, and the election of the Howard Coalition Government in 1996 confined peacekeeping missions to the near region from 1996—2001. This volume is an authoritative and compelling history of Australia's changing attitudes towards peacekeeping.

Jean Bou is a senior lecturer at the Strategic and Defence Studies Centre at the Australian National University. He is the author, co-author or editor of ten books on Australian military history.

Bob Breen is the Director of Professional Practice Qualifications at Deakin University, Victoria, and a Visiting Fellow at the Strategic and Defence Studies Centre at the Australian National University. He is also the author of Volume V of this series, *The Good Neighbour* (Cambridge, 2016).



Painting War

A History of Australia's First World War Art Scheme

Margaret Hutchison

During the First World War the Australian Government established an official war art scheme, sending artists to the front lines to create a visual record of the Australian experience of the war. More than 2000 sketches and paintings were commissioned and acquired between 1916 and 1922, forming the basis of a national collection that continues to have a central place in the way Australians interpret their nation's role in war.

In *Painting War*, Margaret Hutchison examines the official art scheme as a key commemorative practice of the First World War and argues that the artworks had many makers beyond the artists. Government officials and military officers commissioned soldier artists and eminent Australian painters to create images for a collection of art that represented Australia's part in the war for posterity. Their selection of artists and subjects for the war paintings and their emphasis on the eyewitness value of the images over their aesthetic merit profoundly shaped the character of the art collection. Their approach continues to influence the manner in which successive official war artists have represented the Australian Army and other services in their work.

Richly illustrated, *Painting War* is the first book to examine in depth the genesis of one of Australia's most enduring forms of commemoration. It provides an important understanding of the individuals, institutions and the politics behind the war art scheme that helped shape a national memory of the First World War for Australia.


